## **Publicity Consent Conditions of Use**

- 1. Photos of your child will only be used where consent is in place, through return of the Publicity Consent document.
- This form is valid from the date you sign it for the period of time your child attends this school. The consent will automatically expire after this time. You may withdraw consent at any point by contacting the school.
- We will not re-use any photographs or recordings after your child leaves our school other than in school brochures/website already published. You may withdraw consent at any consent by contacting the school.
- 4. We will not use the first name and surname together of any child or adult in a photographic image, on video, on our website, in our school prospectus or in any of our other printed publications, unless agreed by you on the consent form.
- 5. We will not include personal e-mail or postal addresses, or telephone on video, on our website, in our school prospectus or in any of our other printed publications.
- 6. We may include pictures of pupils and teachers that have been drawn by the pupils.
- 7. We may use group or class photographs or footage with very general labels, such as "a science lesson" or "making Christmas decorations".
- 8. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
